The (multi-year) policy plan

We have no multi-year policy plan. We are a small organization, and are looking for methods to increase our exposure in the Netherlands, without spending large sums of money to promote our activities.

The objective and the current policy

The purposes, goals, objectives and intentions for which the Company was founded in Israel as well as in the Netherlands, are to perform lawful activity, serving as a Charity (non-profit) as follows:

- To promote and create public awareness and appreciation for Israel from a Biblical perspective, by acting in the dissemination of information, reports and materials concerning Israel and her struggle to exist, her general social condition and her various streams of thought.
- To organize, sponsor, finance and conduct classes, conferences, workshops, lectures, presentations, seminars and meetings held in Israel and abroad, as well as initiate, sponsor and support the production, sales, supply and distribution of explanatory media, materials and information about Israel and Biblical themes, for the public's benefit.
- To encourage and foster immigration of Jews to Israel, and tourism for others, to Israel.
- To provide financial assistance, relief and aid to individuals, companies and other bodies in financial distress and/or which are in need of assistance and help in the form of grants and loans at no interest, and by providing assistance in other forms, without compensation, to the needy in Israel.

The goals and objectives of our organization in Holland

Traditionally, the dominant religion in Holland is Christianity, according to statistical data, from 2016. Various Christian denominations, together with the Roman Catholic Church make up over 24.5% of population. The only single "religion" in the Netherlands that enjoys persuading a higher percentage of the population is "no religion at all," whose numbers have reached 67.8% in 2016.

Our goals and objectives seek to build bridges of understanding between Christians and Jews in the State of Israel, from whom their Holy Book — the Bible — was forged. One of the ways we do this is to provide new, and far more accurate bible translations from the earliest New Testament manuscripts available today. This represents a work that no other individuals or organizations are doing today, and we are happy to continue this good work. In order to do so, we require opportunities to meet and dialog with Christians and even those who have no religion in the Netherlands, to inform them about the new translations that we are producing of the New Testament, which contain a life-changing message that also provides an added benefit of drawing the Christians of Holland with the Jewish People residing in Jerusalem and throughout Israel.
